Terms and Conditions:

1. PAYMENT

- a. A deposit of \$300.00 paid to the breeder is required in advance and the balance of the purchase price of the puppy is to be paid upon delivery/receipt of the puppy. Vaccinations for the puppy will be up to date and records of such care will be supplied with the puppy.
- b. The breeder will rebate up to \$150 upon successful completion of one of the following titles:
 - A CKC title of : Champion (Ch), Companion Dog (CD), Field Dog Junior (FDJ), Tracking Dog (TD), Intermediate Agility (AgI)
 - A NAVHDA prize: NA, UPT, UT
 - 2 of the following titles: WAC/WCA ratings test qualifiers (NRD, NSD), Canine Good Neighbor (CGN), Agility Novice (AgN)

2. HEALTH GUARANTEE

- a) The buyer agrees to have the puppy examined by their veterinarian within seventy two (72) hours of receiving the puppy. If the puppy is determined to be unsound or in poor health at that examination, the Buyer can elect to keep the puppy, assuming all costs for it's care, or may return the puppy for a refund of the purchase price upon the Breeder's receipt of the Veterinarians statement regarding the puppy's health.
- b) **Up to 1 year of age:** If the puppy should be diagnosed with a serious or life threatening hereditary health condition, the puppy may be returned to the breeder for a full refund of the purchase price or a replacement puppy (upon receipt of a written and qualified Veterinarian's statement regarding the puppy's health). The decision between a full refund of the purchase price or a replacement puppy is solely the breeders. Should the Buyer elect to keep the puppy, a payment of seventy five percent (75%) of the purchase price, or the cost of treatment, (whichever is the lesser amount) will be refunded by the breeder, or the breeder may elect to replace the puppy.
- c) **Up to 2 years of age:** If the puppy should be diagnosed with a serious or life threatening hereditary health condition, the puppy may be returned to the breeder for seventy five percent (75%)of the purchase price or a replacement puppy (upon receipt of a written and qualified Veterinarian's statement regarding the puppy's health). The decision between a refund of the purchase price or a replacement puppy is solely the breeders. Should the Buyer elect to keep the puppy, a payment of fifty percent (50%) of the purchase price, or the cost of treatment, (whichever is the lesser amount) will be refunded by the breeder, or the breeder may elect to replace the puppy.
- d) **Up to 3 years of age:** If the puppy should be diagnosed with a serious or life threatening hereditary health condition, the puppy may be returned to the breeder for fifty percent (50%)of the purchase price or a replacement puppy (upon receipt of a written and qualified Veterinarian's statement regarding the puppy's health). The decision between a refund of the purchase price or a replacement puppy is solely the breeders. Should the Buyer elect to keep the puppy, a payment of twenty five percent (25%) of the purchase price, or the cost of treatment, (whichever is the lesser amount) will be refunded by the breeder, or the breeder may elect to replace the puppy.
- e) The Buyer agrees to ensure the puppy receives its' vaccination booster, only as recommended by the breeder, at the required intervals and will continue to maintain an adequate vaccination

schedule/or collect titers to ensure proper immunity is maintained for the following diseases: Parvovirus, Distemper and Rabies. The Buyer will also ensure the puppy receives appropriate heart worm preventative, every 30 to 45 days, in areas where heart worm is endemic and after visiting an area where heart worm is endemic. A vaccination schedule is provided.

Failure to adhere to this schedule will void all guarantees and may seriously affect the health of your puppy.

3. CARE

a) The Buyer agrees to provide for the complete care of the dog above and beyond the necessities of life including, but not limited to, proper diet, veterinary care and daily exercise. The Buyer agrees to confine the dog to a crate or restricted area, when the animal is alone or unattended. The Buyer agrees **never** to let the dog run loose, unattended unless properly confined in a fenced yard or kennel run. The dog will **never** be chained outside while unattended.

Note: Underground fencing has proven unreliable in containing a Weimaraner.

b) If the puppy is not personally kept by the Buyer, the puppy must be returned to Shelly Shorrock (return shipment method to be arranged). The puppy is not to be sold or given away to any other person. Paperwork will be completed transferring full ownership to Shelly Shorrock. Shelly Shorrock will arrange placement of the dog in a new home where the best interests of the dog will prevail and not the monetary concerns of the Buyer or Breeder.

c) All medical, training, showing and other expenses are to be the responsibility of the Buyer, who will also be responsible for any damages the dog may incur.

4. OTHER

This dog is sold on a Non-Breeding agreement with the Breeder. This dog will not be used for breeding unless the following conditions are met.

1. Acceptable Conformation and/or Performance titles will have been achieved.
2. Health Clearances will be achieved, including but not limited to: hip, thyroid and eyes.
3. The breeding will be agreed to in writing by Shelly Shorrock.
4. 4. The selected stud dog will be approved of by Shelly Shorrock.

Any violations of the terms of this contract on behalf of the Buyer renders any and all guarantees, warrants and assurances null and void. The Breeder reserves the right to take possession of the dog in the instance of severe neglect or cruelty of the dog or severe breach of this contract.
